My research was based on the application of the test called "Pragmatics Profile of Early Communication Skills" (Dewart & Summers 1988), after translating and adapting it to the Greek language. The results of the research showed that the communication gradient was similar in the two groups of children, although the way of conducting communication per group was different.
- Case study of a dysphasic adult (1993)

This study aims to present a patient with dysphasia who was provided with individual and group speech and language therapy in a London hospital. In particular, the aetiology of the stroke, the brain injury, the symptomatology of the case and the stages of speech and language therapy, i.e. the diagnosis, the specific therapeutic exercises followed, the goals of the treatment and the evolution of the patient's speech and language status are described. Finally, a critical review of the speech therapy carried out is attempted.
